WOMEN'S AND GIRLS' GARMENTS.

With reference to the notice which was published in the London, Edinburgh and Belfast Gazettes of the 2nd November, 1934, regarding a reference made by the Board of Trade to the Standing Committee under the Merchandise Marks Act, 1926, in respect of women's and girls' garments of the following descriptions, of woven fabrics:—

- (1) Costumes, dresses, coats, skirts and the like.
- (2) Blouses, jumpers, and the like.
- (3) Mantles and cloaks.
