MINISTRY OF TRANSPORT.

In the Matter of the London Traffic Act, 1924.

Notice is hereby given that the Minister of Transport, in exercise of the powers conferred on him by Section 10 of the London Traffic Act, 1924, has, by virtue of Section 2 of the Rules Publication Act, 1893, made the London Traffic (Parking Places) (Amendment) (No. 2) Provisional Regulations, 1935, to come into force forthwith as Provisional Regulations and to continue in force until Statutory Rules have been made in accordance with the last-mentioned Act.

These Regulations, which amend the London Traffic (Parking Places) Consolidation Provisional Regulations, 1934, provide for

- (1) the appointment of parking places in the undermentioned thoroughfares:—Comyn Road, Clapham Junction; Eckstein Road, Clapham Junction; Banbury Road, Hackney; Boleyn Road, Dalston; Clapton Square, Hackney; Croston Street, Hackney; Crozier Terrace, Homerton; De Beauvoir Square, De Beauvoir Town; Evering Road, Stoke Newington; Homerton Grove, Hackney; Kenninghall Road, Hackney; Roseberry Place, Dalston; Smalley Road, Stoke Newington; Wilton Road, Hackney; South Crescent, Holborn; Hoxton Square, Shoreditch; Palace Grove, Bromley; St. Blaise Avenue, Bromley; North Road, Highgate; Queen's Road, Ilford; Sylvan Road, Ilford; Wakefield Road, Richmond; Whittaker Avenue, Richmond; High Street, Southall; Grove Road, Wanstead; Sylvan Road, Wanstead; Woodbine Place, Wanstead.
- (2) the alteration of the position in which vehicles may wait on the car parks in Ambrosden Avenue, Westminster, Berkeley Square, Westminster, and Ravensbourne Road, Bromley.
- (3) the revision of (a) the "limits" of the car park in Bedford Square, Holborn, so as to increase the accommodation thereat, (b) the curtailment of the "limits" of the car park in Caxton Street, Westminster, so as to avoid obstruction to shop frontages, (c) the curtailment of the "limits" of the car park in Great Marlborough Street, Westminster, in view of the alternative facilities available in the locality, and
- (4) the abolition of the parking places in Ladbroke Road, Redhill, and St. John's Road, Wembley.
