DISEASES OF ANIMALS ACTS, 1894 TO 1927.

Notice is hereby given, in pursuance of section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made an Order dated 27th May, 1935, relating to the quarantine of certain dogs.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Rochdale Vicarage Act, 1866 (twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, Chapter eighty-six), and also in pursuance of the Act of the twenty-ninth and thirtieth

years of Her said late Majesty, Chapter one hundred and eleven, do hereby, subject as hereinafter mentioned, grant out of the "Rochdale Vicarage Fund" created under the tenth section of the said Rochdale Vicarage Act, 1866, to (1) the Incumbent of the Benefice of Falinge, in the County of Lancaster and in the Diocese of Manchester, one yearly sum or stipend of seventy pounds, and (2) the Incumbent of the Benefice of Healey, in the same county and diocese, one yearly sum or stipend of thirty pounds, such yearly sums or stipends to be calculated as from the first day of February in the year one thousand nine hundred and thirty-five and to be payable in equal quarterly portions on the first day of February, the first day of May, the first day of August and the first day of November in each and every year; Provided always that the said yearly sum or stipend hereby granted to the Incumbent of the said Benefice of Falinge shall terminate upon the cessation of the pension charged on the revenues of such Benefice in favour of the Reverend James Botton Phillips and that the yearly sum or stipend hereby granted to the Incumbent of the said Benefice of Healey shall terminate upon the cessation of the pension charged on the revenues of that Benefice in favour of the Reverend Charles Spenser Rowland.

BASLOW AND DISTRICT GAS.

(Application for a Special Order under the Gas Undertakings Acts 1920 to 1934).

3. To authorise the Company to continue, maintain and use any mains, pipes and works acquired, laid down or constructed by or belonging to them within the limits of supply
