and to apply to such mains, pipes and works the provisions of the intended Order and of the Acts incorporated therewith.

4. To empower the Company to maintain, erect, alter, improve and renew gasworks with all necessary machinery and apparatus and to make and store gas and to work up and convert residual products upon the lands hereinafter described and to purchase and use material required to work up and convert residual products.

The said lands are:-

All that piece of freehold land now in the occupation of the Company containing 1 rood 23 perches 12 square yards or thereabouts situate in the parish of Baslow and Bubnell in the county of Derby bounded on or towards the north in part by land belonging or reputed to belong to the Duke of Devonshire and in the remaining part by a road leading from Church Lane to Park Side on or towards the east and west respectively by other land belonging or reputed to belong to the Duke of Devonshire and on or towards the south by the brook known as Bar Brook.

- 5. To make provision as to the supply of gas to premises abutting on streets forming the boundary of the limits of supply and as to the breaking up of streets for the purpose of affording such supply.
- 6. To make provision as to the purity pressure and testing of the gas to be supplied by the Company within the limits of supply and as to the maximum price for such gas.
- 7. To authorise the Company to expend moneys for the purposes of the intended Order, and to make provision as to the sums to be receivable by the Company by way of dividend or interest on those moneys and as to the application of the revenue and profits of and the keeping of accounts in respect of the undertaking to be authorised by the intended Order.
- 8. To empower the Company to purchase by agreement, hold, sell and lease lands and to purchase, take on lease, erect, fit up, maintain, and let houses for employees and offices, showrooms and other buildings.
 - 9. To make provision with respect to:-

The specification and regulation of the materials, size and position and the laying of pipes, fittings and appliances on the premises of consumers; the laying of pipes in private streets; the laying of pipes for ancillary purposes; the refusal to supply and the cutting off of supplies of gas and the recovery of the cost of such cutting off; the supply and installation of and property in fittings and the exemption thereof from distress or execution; the prevention of the improper use of gas; the inspection and testing of meters and the expense thereof; charges for special readings of meters; and the inclusion of several sums in one summons.

10. To make all usual or convenient provisions incidental to the aforesaid purchase and for enabling it to be carried into effect, and such other provisions as may be deemed (181)

expedient for effecting the purposes of the intended Order.

- 11. To confer upon the Company all other powers commonly conferred upon gas undertakers.
- 12. The Order will vary or extinguish all rights and privileges which would impede or interfere with its purposes and confer other rights and privileges.
- 13. To incorporate with or extend and apply for the purposes of the intended Order the provisions of the Companies Clauses Consolidation Act, 1845, the Lands Clauses Acts, the Gasworks Clauses Acts, 1847 and 1871, the Gas Undertakings Acts, 1920 to 1934, and the Arbitration Acts, 1889 to 1934, with modifications and exceptions and to exempt the Company from some of the provisions of those Acts and to amend or repeal or incorporate with or extend and apply for the purposes of the Order all or some of the provisions of the Sheffield Gas (Consolidation) Act, 1929, the Sheffield Gas Act, 1931, and other Acts or Orders relating to the Company.

Any local or public authority company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the 28th day of June, 1935.

Any such objection shall state: -

- (a) the specific grounds of objection; and
- (b) the omissions, additions or modifications asked for.

A copy of the objection must at the same time be forwarded to the undermentioned Solicitors or Parliamentary Agents.

A copy of the draft Order and an Ordnance Map showing the situation of the existing works of the Company and of the works referred to in paragraph 4 of this Notice and the boundaries of the Company's existing limits of supply and of the limits of supply referred to in paragraph 2 of this Notice have been deposited for public inspection at the office of the Company at the aforesaid address, at The Gas Works, Baslow, Derbyshire, and at the offices of the respective Clerks of the Peace for the County of Derby at County Offices, St. Mary's Gate, Derby; for the West Riding of the County of York at County Hall, Wakefield; for the City of Sheffield at 2, Meetinghouse Lane, Sheffield; and for the County Borough of Rotherham at the Town Hall, Rotherham.
