(3) Any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the Urban Districts of Loftus, Malton, Pickering, Skelton and Brotton, and Whitby, and the Rural Districts of Aysgarth, Bedale, Croft, Easingwold, Flaxton, Helmsley, Kirbymoorside, Malton, Masham, Northallerton, Reeth, Richmond, Scarborough, Startforth, Stokesley, Wath and Whitby, and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the said County Council to register without charge his or their name and address for the service of subsequent notices relating to the scheme.
