ROAD TRAFFIC ACT, 1930—SECTION 19 (AS AMENDED).

Notice is hereby given that the Minister of Transport has received an application from the Brewers' Society being an organisation representative of employers in a section of the road transport industry concerned with the conveyance of goods by road, which the Minister of Labour has certified to be a proper body to make such an application, for the variation during certain seasons of the year of the periods of driving time prescribed by Section 19 of the Road Traffic Act, 1930, as amended by Section 31 of the Road and Rail Traffic Act, 1933, for the employment of drivers of road vehicles of certain types.

As provided in sub-section (3) of Section 19 of the Road Traffic Act, 1930, as amended, the Minister has referred the matter to the Industrial Court for advice. The Court has fixed Thursday, 20th June, 1935, at 10.30 a.m., at No. 5, Old Palace Yard, Westminster, S.W.1, as the time and place for hearing parties to the application.

Copies of the proposals contained in the application for the variation of the periods of time laid down in Section 19 of the Act can be obtained from the Secretary of the Industrial Court at the address given above.

Persons representing organisations of employers or workpeople in the industry who may desire to make representations to the Court in the matter, should either give notice beforehand to the Secretary of the Industrial Court that they desire to be heard or submit their representations in writing to the Secretary.

ROAD TRAFFIC ACT, 1934.

Notice is hereby given that the Minister of Transport under and by virtue of the provisions of paragraph (b) of sub-section (4) of Section 1 of the Road Traffic Act, 1934, intends to make an Order the effect of which will be that the undermentioned lengths of road shall be deemed not to be roads in a built-up area for the purposes of the said Section:—

London—Bath Road (A.4) from a point 200 yards East of Langley Cross Roads, Slough, to a point 100 yards East of the junction with Langley Road, Slough.

Great South-West Road (A.30) from the junction with the Chiswick—Isleworth—East Bedford Road (A.315) to a point 600 yards East of the junction with Stanwell New Road (B.379).

The draft Order, which will also consolidate the Road Traffic Act, 1934 (Directions under paragraph (b) of sub-section (4) of Section 1) Orders, 1935, dated 8th March, 1935, and 17th May, 1935, may be inspected at the Ministry of Transport, 7, Whitehall Gardens, S.W.1, and copies thereof may be obtained from the Ministry, price one penny per copy.

RULES PUBLICATION ACT, 1893.
