The following Statutes made by the University of Cambridge, on the 28th day of June, 1935, have been submitted for the approval of His Majesty in Council, and notice of their having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

UNIVERSITY OF CAMBRIDGE.

STATUTES TO ALTER AND AMEND THE STATUTES IN BELATION TO THE UNIVERSITY OF CAMBRIDGE, MADE UNDER "THE UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923" (13 & 14 GEORGE V, CHAPTER 33), WHICH AMENDING STATUTES ARE NOW SUBMITTED FOR THE APPROVAL OF HIS MAJESTY THE KING IN COUNCIL.

We, The Chancellor, Masters, and Scholars of the University of Cambridge, in pursuance of the power given to us by the 7th Section of the Universities of Oxford and Cambridge Act, 1923, do hereby alter and amend the Statutes made under that Act in relation to our said University in manner following, that is to say:—

STATUTE D.

CHAPTER II.

THE UNIVERSITY ADMINISTRATIVE OFFICERS.

By amending Section 5 so as to read as follows:

5. (a) The Council may dispense a University administrative officer, on account of

his illness, from discharging the duties of his office until a date not later than six months after the commencement of his absence from duty, without loss of stipend. The Council may extend such dispensation and if it does so shall fix the amount (if any) of the stipend payable to him.

(b) The Council may dispense a University administrative officer, for sufficient cause other than his illness, from discharging the duties of his office until a date not later than twelve months after the commencement of his absence from duty. No stipend shall be payable to him during such dispensation unless at the time of giving it or at the time or times (if any) of extending it (provided that on no account shall it cover a total period exceeding twelve months) the Council, having regard to all the circumstances of the case, including the nature of the sufficient cause and the question whether he is receiving or will receive payment from some source other than the University during his absence from the duties of his office, shall have determined that the whole or a part of his stipend shall be payable to him.

CHAPTER VII.

THE REGISTRARY, THE SECRETARY GENERAL OF THE FACULTIES, ASSISTANT REGISTRARIES.

By adding a new section as follows:

9. Notwithstanding anything contained in these Statutes, whenever a vacancy in the office of Secretary General of the Faculties has occurred, or in the opinion of the Council is about to occur, the Regent House, either
