# COUNTY OF DEVON.

ROAD TRAFFIC ACT, 1930.

## ROAD AND RAIL TRAFFIC ACT, 1933.

NOTICE is hereby given that on the 13th July, 1935, the Minister of Transport modified and confirmed the County of Devon Roads (Restriction) (No. 3) Order, 1934, made by the Devon County Council on the 14th June, 1934, under Section 46 of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933.

The Order as modified provides that :---

(1) Subject to certain exceptions, no person shall drive or cause to be driven on the roads specified in the First Schedule hereto any heavy locomotive, light locomotive, motor tractor, or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930), or any motor car with seats for more than fourteen persons exclusive of the driver.

(2) No person shall drive or cause to be driven any vehicle on any road specified in the first column of the Second Schedule hereto otherwise than in the direction specified in the second column of that Schedule.

(3) Subject to certain exceptions no person shall drive or cause to be driven any motor vehicle of any of the types classified in Section 2 of the Road Traffic Act, 1930 (except invalid carriages) on any of the roads specified in the Third Schedule hereto.

(4) No person shall drive or cause to be driven on the road specified in the Fourth Schedule hereto any vehicle in such a manner that the speed thereof shall exceed ten miles per hour.

## FIRST SCHEDULE.

Urban District of Buckfastleigh.

1. Road from the factory entrance near the Gas Works at Buckfast via Fritz's grave to Hockmoor Head.

#### Rural District of Newton Abbot.

2. Road from its junction with the Manaton-Bovey Tracey Road at Leighon Cross to its junction with the Widecombe-in-the-Moor-Bovey Tracey Road near the Moorland Hotel, Ilsington.

3. Road leading from Barramoor Bridge via Hele Cross to the Princetown-Moretonhampstead Road (B. 3212) at Wormhill.

#### Rural Districts of Newton Abbot and Okehampton.

4. Road from its junction with the Exeter-Princetown Road about Three miles One furlong west of Moretonhampstead via Langaford Bridge to the Cross Roads on the Chagford-Princetown Road, about half a mile north of Jurston.

5. Road from its junction with the Exeter-Okehampton Road (A. 30) at Sticklepath via the Hamlet of Skaigh to its junction with the Belstone-Sampford Courtenay Road at Belstone.

## Rural District of Torrington.

6. Road leading from the Post Office, Weare Gifford, to its junction with the lane leading to lower Southcott at Footlands Cross,
