And whereas the Board of Trade by Direction dated the 21st March, 1934, provided for the assignment as therein mentioned of Receiving Orders made by the said Courts to Mr. Leslie Arthur West and to Mr. Rudolf Kynoch Clark.

And whereas the Board of Trade by minute dated the 26th July, 1935, appointed Mr. Percy Manley Milward to be Official Receiver for the Bankruptcy Districts of the County Courts holden at Manchester, Salford, Ashton-under-Lyne and Stalybridge, Bolton, Oldham, Rochdale and Stockport, as from the 1st August, 1935, in the place of Mr. Rudolf Kynoch Clark.

Now therefore the Board of Trade by virtue of Rule 308 of the Bankruptcy Rules 1915, hereby vary the above recited Direction dated the 21st March, 1934, and hereby direct that where Receiving Orders have been made by the said County Courts holden at Ashton-under-Lyne and Stalybridge, Bolton, Oldham, Rochdale and Stockport respectively prior to the 1st August, 1935, and are pending at that date, and where Receiving Orders are made on and after the 1st August, 1935, by the last mentioned County Courts respectively, Mr. Percy Manley Milward shall be Official Receiver in the place of Mr. Rudolf Kynoch Clark for the purposes of such Receiving Orders and the estates thereunder shall be assigned to him.

This Direction shall have effect as from and including the 1st August, 1935.
