acquired any other nationality by naturalization or by any other voluntary and formal act.

- 5. The subjects of examination are the following:-

 English.

 - (3) General Paper.

Candidates must pass to the satisfaction of the Civil Service Commissioners in Shorthand and in the aggregate of the three subjects.
