The proposed extended route will lie via Rhiwbina Road, Pantmawr Road, Park Road (Merthyr Road), and vice versa and the extension will be operated so that both the Whitchurch and Rhiwbina Services may be run in conjunction with each other to form a circular service via North Road, Park Road (Merthyr Road), Pantmawr Road, Rhiwbina Road, Heol-y-Deri, Pantbach Road, Philog Road (Birchgrove), Caerphilly Road and North Road and vice versa.

Any Local Authority, the Council of any County or any persons who are already providing transport facilities on or in the neighbourhood of any part of any route to which the application relates, may make objection or representations in writing and shall state the grounds on which they are based, addressed to the Traffic Commissioners for the South Wales Area, Graham Buildings, Newport Road, Cardiff, on or before the 29th day of August, 1935.

NORTH EAST CHESHIRE REGIONAL PLANNING SCHEME.

BOROUGH OF DUKINFIELD PLANNING SCHEME.

NOTICE is hereby given that (1) on the eighth day of August, 1935, the Minister of Health notified his approval of the resolution of the Town Council of the Borough of Dukinfield dated the thirteenth day of May, 1935, deciding to prepare a town planning scheme with reference to an area situate wholly within the Dukinfield Municipal Borough; (2) the map defining the area to which the resolution applies has been deposited at the Town Clerk's Office, Town Hall, Dukinfield, and will be open for investigation by all persons interested without charge from Monday to Friday between the hours of 9 a.m. and 5 p.m. and on Saturdays between the hours of 9 a.m. and 12 noon; (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the said Borough of Dukinfield and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the North East Cheshire Regional Planning Committee (to which the Committee the Town Council of the Borough of Dukinfield have delegated all their powers under the Town and Country Planning Act, 1932) to

register without charge his or their name and address for the service of the subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933, the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Town Council of the Borough of Dukinfield are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The North East Cheshire Regional Planning Committee intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Clerk of the North East Cheshire Regional Planning Committee.
