

hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas there has been contributed and paid to the credit of our account at the Bank of England a capital sum of £2,000 towards the cost of erecting a permanent Church within and for the said proposed separate District:

"And whereas the said capital sum of £2,000 has been contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of patronage of the said proposed District, and, when such District shall have become a New Parish, then of the said New Parish, and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

"And whereas the contributors of the said capital sum of £2,000 towards the cost of erecting such permanent Church have nominated to us the Archbishop for the time being of the said Diocese of Canterbury as the person to whom they desire that the whole right of patronage of the said proposed District or New Parish should be assigned:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, now Archbishop of Canterbury (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said Parish of West Wickham which is described in the Schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual purposes, and that the same shall be named 'The District of Saint Francis of Assisi, West Wickham'.

"And we further recommend and propose that the whole right of patronage of the said District so recommended to be constituted and, when such District shall have become a

New Parish as aforesaid, then of the said New Parish, and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in the said Cosmo Gordon, Archbishop of Canterbury, and his successors, Archbishops of Canterbury, for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Francis of Assisi, West Wickham, being:—

"All that part of the Parish of West Wickham, in the County of Kent and in the Diocese of Canterbury, which is bounded upon the west by the Parish of Addington, in the County of Surrey and in the said Diocese of Canterbury, upon the north-west partly by the New Parish of Christ Church, Beckenham, and partly by the New Parish of Saint Barnabas, Beckenham, both in the said County of Kent and in the Diocese of Rochester, and upon the remaining sides, that is to say, upon the north-east and upon the south-east by an imaginary line commencing at the point where the boundary which divides the said New Parish of Saint Barnabas, Beckenham, from the said Parish of West Wickham crosses the middle of the Hayes Branch Line of the Southern Railway, and extending thence south-eastward along the middle of the said line of railway for a distance of $57\frac{1}{2}$ chains or thereabouts to a point opposite to the north-eastern end of the wall or fence forming the western boundary of the Hawes Down Council School, and extending thence first south-westward to and then first south-westward, then south-eastward and then again south-westward along the said wall or fence for a distance in all of 14 chains or thereabouts to the point where it reaches the northern side of Hawes Lane, and extending thence first south-westward to and then south-eastward along the middle of Hawes Lane for a distance of $3\frac{1}{2}$ chains or thereabouts to a point opposite to the north-eastern end of the wall or fence forming the south-eastern boundary of the houses and premises situate on the south-eastern side of Silver Lane, and extending thence south-westward to and along the said wall or fence for a distance of $18\frac{1}{2}$ chains or thereabouts to the point where it meets the wall or fence forming the north-eastern boundary of the West Wickham Bowling Club Ground, and extending thence north-westward along the last mentioned wall or fence for a distance of $2\frac{1}{2}$ chains or thereabouts to the point where it reaches the southern side of Silver Lane, and extending thence north-westward along the southern side of Silver Lane for a distance of 5 yards
