25th day of July, 1935, in the words and

figures following, that is to say:—
"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the 23rd and 24th years of Her late Majesty Queen Victoria, Chapter 142, have prepared, and now humbly lay before Your Majesty in Council, the following further Supplemental Scheme under the 25th Section of that Act with reference to the United Benefice and Rectory of Saint Luke with Saint Paul, Old Charlton, in the County of Kent and in the Diocese of Southwark:

"Whereas by an Order of His late Majesty King Edward the Seventh in Council bearing date the 1st day of August, 1908, and published in the London Gazette on the 11th day of the same month it was directed, inter alia, that the Parsonage House of the Rectory of Saint Luke, Charlton, should be sold and disposed of by us, the said Ecclesiastical Commissioners, and that the net proceeds arising from such sale should form one aggregate fund and should be applied (1) to the provision of a capital sum not exceeding £2,000 for or towards the acquisition of a suitable site for and the erection of or otherwise for the provision of a Parsonage House for a new district to be constituted wholly or in part out of the United Parish of Saint Luke with Saint Paul, Old Charlton, and (2) to the endowment or augmentation of the income of the Minister or Incumbent of the said proposed new district:

"And whereas by the same Order in Council it was provided that the Incumbent for the time being of the said United Benefice of Saint Luke with Saint Paul, Old Charlton, should, out of the endowments and income of such United Benefice, pay a stipend of not less than £150 per annum to an Assistant Curate to

serve the said United Parish:

"And whereas by an Order of Your Majesty in Council bearing date the 22nd day of December, 1921, and published in the London Gazette on the 30th day of the same month it was directed that out of the interest arising from the aggregate fund representing the proceeds of the sale of the said Parsonage House of the Benefice of Saint Luke, Charlton, a sum of £100 per annum should be appropriated and should be paid to the Incumbent for the time being of the said United Benefice of Saint Luke with Saint Paul, Old Charlton, subject to the employment within the said United Parish of two Assistant Curates duly licensed by the Bishop of the said Diocese of South-

wark:
"And whereas by another Order of Your Majesty in Council bearing date the 22nd day of March, 1928, and published in the London Gazette on the following day it was directed that out of the interest arising from the aggregate fund held by us and representing the proceeds of the sale of the said Parsonage House of the Benefice of Saint Luke, Charlton, a capital sum of £800 should be appropriated and should be applied by us towards the provision of a House of Residence for an Assistant Curate serving within the said United Parish:

"And whereas by another Order of Your Majesty in Council bearing date the 27th day of October, 1930, and published in the London Gazette on the 4th day of the following month, it was directed (first) that the capital sum of £800 hereinbefore mentioned should no longer be held by us towards the provision of a House of Residence for an Assistant Curate serving within the said United Parish but should fall back into and again form part of the said aggregate fund, (secondly) that out of the interest arising from such aggregate fund a second yearly sum of £100 should be appropriated and should be paid to the Incumbent for the time being of the said United Benefice of Saint Luke with Saint Paul, Old Charlton, to be applied by him towards the stipend of an Assistant Curate serving such United Parish upon condition that such Assistant Curate is in receipt of a stipend at a rate of not less than £250 per annum, and (thirdly) that the stipend of the Assistant Curate in respect of whose services the payment of £100 per annum mentioned in the said Order in Council of the 22nd day of December, 1921, is made, shall be at the rate of not less than £200 per annum instead of £250 per annum as therein mentioned :

"And whereas it has been represented to us that by reason of changes in the circumstances of the said United Parish (first) it is no longer advisable that a new district shall be constituted wholly or in part out of the said United Parish of Saint Luke with Saint Paul, Old Charlton, and (secondly) the stipend of not less than £150 per annum payable in accordance with the provisions of the said Order in Council of the 1st day of August, 1908, out of the endowments and income of the said United Benefice to an Assistant Curate to serve the said United Parish, should be reduced to a

sum of not less than £50 per annum:

"Now, therefore, with the consent of the Right Reverend Richard Godfrey, now Bishop of Southwark (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), with the consent of Sir Spencer Pocklington Maryon Maryon-Wilson, Baronet, of Eastborne (in testimony whereof he has signed and sealed this Scheme), and with the consent of the Parochial Church Council of the said United Parish of Saint Luke with Saint Paul, Old Charlton (in testimony of which consent this Scheme is signed by the Chairman presiding at a Meeting of the Parochial Church Council held for the purpose of giving such consent and by two other Members of the Council present at such Meeting), we, the said Ecclesiastical Commissioners, humbly recommend and propose that as from the 1st day of May, 1935, first, the said Order in Council of the 22nd day of December, 1921, and those portions of the said Order in Council of the 1st day of August, 1908, relating to the said aggregate fund representing the proceeds of the sale of the Parsonage House of Saint Luke, Charlton, and also those portions of the said Order in Council of the 27th day of October, 1930, relating to the interest arising from and in respect of the said aggregate fund shall be rescinded; secondly, the said aggregate fund shall be held by us in equal moieties in respect of each of which moieties and of any further sums which may be added to such moieties as hereinafter mentioned there shall be paid by us to the Incumbent for the time being of the said United Benefice of Saint Luke with Saint Paul, Old Charlton, a yearly sum to be calculated at the rate of £3 per centum per annum and to be receivable in equal quarterly portions on the 1st day of February, the 1st day of May, the
