"(3) (a) The Officers administering the said Governments shall meet in conference on matters relating to the services as and when occasion arises; provided that such meetings shall take place at least twice in each year.

(b) In the event of the said Officers failing to reach agreement on any matter relating to the services, such matter shall be referred to the Secretary of State for his decision."

(3) By the insertion of the words "road motor services, aircraft services" between the words "railways" and "ports" which appear in Article 3 thereof.

(4) By re-numbering Article 4 thereof as Article 4 (1) and by inserting the following sub-Article as sub-Article 4 (2).

"(2) All acts done by the High Commissioner and all forms and documents used and entered into shall be in the name of the Services."

2. This Order may be cited as the Kenya and Uganda (Transport) Amendment Order in Council, 1935, and shall be read as one with the Kenya and Uganda (Transport) Orders in Council, 1925 and 1927, and the said Orders may be cited as the Kenya and Uganda (Transport) Orders in Council, 1925, 1927 and 1935.
