WAR LOAN REDEMPTION OF SECURITIES.

AMENDING REGULATION MADE BY THE TREASURY UNDER SECTION 8 OF THE WAR LOAN ACT, 1919 (9 & 10 GEO. 5, C. 37) FOR THE DRAWING OF 4 PER CENT. VICTORY BONDS (BANK ISSUE).

In pursuance of Section 2 of the Act 9 & 10 Geo. 5, c. 37, the Lords Commissioners of His Majesty's Treasury make the following Regulation:—

In Articles 3 and 5 respectively of the Regulations dated the 29th May, 1920, made by the Treasury in pursuance of the said Section of the said Act, the expression "a Director of the Bank nominated by the Governor of the Bank of England or in his absence by the Deputy Governor" shall be substituted for the expression "a Director of the Bank who has served as Governor." DANGEROUS DRUGS ACTS, 1920—1932.

WITHDRAWAL OF AUTHORITY.

Whereas Aymer Douglas Maxwell, M.B., Ch.B. (Edin.), of "Kenya," Poulner Road, Ringwood, Hants, has been convicted of offences against the Dangerous Drugs Acts:

And whereas the said Aymer Douglas Maxwell cannot, in my opinion, properly be allowed to be in possession of or to supply any of the drugs or preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

Now, therefore, in pursuance of the powers conferred on me by Regulation 6 of the Raw Opium Regulations, 1921, as extended by the Coca Leaves and Indian Hemp Regulations, 1928, and by Regulation 7 of the Dangerous

Drugs (Consolidation) Regulations, 1928, I hereby give notice that I withdraw, as from to-day's date, from the said Aymer Douglas Maxwell, the authority granted by the said Regulations to duly qualified medical practitioners to be in possession of and to supply raw opium, coca leaves, Indian hemp, and the drugs and preparations to which Part III of the Dangerous Drugs Act, 1920, applies:

And I also direct, as from the same date, that it shall not be lawful for the said Aymer Douglas Maxwell to give prescriptions for the purposes of the Dangerous Drugs (Consolidation) Regulations, 1928.
