Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish of Ashbury save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as

follows, viz.:-

ASHBURY.—Forthwith and entirely in the Parish Church of Saint Mary the Virgin, in the said Parish, and in the Old Church-yard attached thereto.

Provided that-

In the vault now existing in the said Churchyard and belonging or reputed to belong to the Brown family, the burial may be allowed at their decease of the bodies of Harold Pearce Brown, John Pearce Brown, Frank Pearce Brown and Alexander Pearce Brown subject to the condition that every coffin buried in such vault be separately enclosed by stonework or brickwork properly cemented.
