#### LONDON PASSENGER TRANSPORT BOARD.

**N**OTICE is hereby given that the London Passenger Transport Board (hereinafter called "the Board") have applied to Parliament for leave to introduce in the present Session a Bill under the above short title and intituled "A Bill to empower the London Passenger Transport Board to provide certain services of trolley vehicles; to construct new works; to acquire lands; to raise additional moneys; to confer further powers on the Board; and for other purposes."

A Notice containing a concise summary of the purposes of the Bill has been or will be published in full in the Times newspaper on the 4th and 11th days of December 1935.
