KENDAL GAS.

(Application for Special Order under the Gas Undertakings Acts, 1920 and 1929.)

NOTICE is hereby given that application is intended to be made to the Board of Trade by the Mayor Aldermen and Burgesses of the Borough of Kendal (hereinafter referred to as "the Corporation"), whose address is 14, Kent Street, Kendal, for a Special Order (hereinafter referred to as "the Order") under and in pursuance of the Gas Undertakings Acts, 1920 and 1929, for all or some of the following, amongst other, purposes (that is to say):—

1. To extend the limits within which the Corporation are authorised to supply gas and to authorise them to supply gas within so much of the borough as was transferred thereto by the Westmorland Review Order 1934 from the parishes of Helsington, Underbarrow and Bradleyfield, Natland, Scalthwaiterigg, Skelsmergh and Strickland Ketel (other than such part of the parish of Strickland Ketel as was included in the gas limits of the Corporation by the Kendal Order 1909) and to authorise the Corporation to exercise within the said area all or some of the powers exercisable by them within their existing limits of supply.

2. To enable the Corporation to exercise all such powers as may be necessary or convenient for giving effect to the purposes of the Order, and to confer upon them all such other powers as are usually conferred upon local authorities in connection with the supply of gas.

in connection with the supply of gas.

3. To incorporate with the Order with or without modification or to render inapplicable to the Corporation or their undertaking all or any of the provisions of the Gasworks Clauses Acts 1847 and 1871, and the Interpretation Act, 1889, and the Acts amending, altering, repealing, or re-enacting those Acts respectively.

4. To repeal, alter or amend, or to re-enact or incorporate in the Order, with or without amendment, some or all of the provisions of the Acts and Orders relating to the supply of gas by the Corporation.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the draft Order may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, London, S.W.1, and despatched on or before the thirteenth day of January 1936.

Any such objection shall state-

(a) the specific grounds of objection; and(b) the omission, additions or modificationsasked for.

A copy of the objection must be forwarded to the undermentioned Town Clerk or Parliamentary Agents at the same time as it is sent to the Board of Trade.

Printed copies of the draft Order together with copies of an ordnance map on a scale of not less than one inch to the mile showing the situation of the existing gasworks of the Corporation and the boundaries of the proposed area of supply and of the area in which the Corporation are already authorised to supply gas, have been deposited for public inspection at the offices of the undermentioned Town Clerk at 14, Kent Street, Kendal, and with
