DESTRUCTIVE INSECTS AND PESTS ACTS,  
1877 TO 1927.

Notice is hereby given in pursuance of Section 5 of the Destructive Insects Act, 1877, that the Minister of Agriculture and Fisheries has made the following Order:—

Order No. D.I.P. 582 (Dated 9th December, 1935).

Fruit Tree Pests (Essex) Order of 1935.

This Order empowers officers appointed by the Local Authorities for the County of Essex or the County Borough of East Ham, Southend-on-Sea, or West Ham, or the Borough of Colchester, Ilford, Leyton or Walthamstow, to investigate complaints from fruit growers that fruit trees growing on other premises are likely to cause the spread to their own trees of certain scheduled diseases and pests, and enables the Local Authority to take action to prevent the spread of infection.

ORDER OF THE REGISTRAR-GENERAL  
IN ENGLAND.

(Dated 5th December, 1935.)

Whereas under Sections 10 and 11 of the Births and Deaths Registration Act, 1837, the Registrar-General with the approval of the Minister of Health, may unite two or more superintendent registrars' districts and divide any superintendent registrar's district into two or more superintendent registrars' districts;

And whereas it is expedient that the Cardigan superintendent registrar's district should be divided into two superintendent
