

of the Newcastle-upon-Tyne Registration Scheme, 1935, made by the Council of the County Borough of Newcastle-upon-Tyne and approved by the Minister of Health under Section 24 of the Local Government Act, 1929, become a separate Superintendent Registrar's district and sub-district respectively situate wholly without the said County Borough;

And whereas it is expedient that on the formation of the separate Superintendent Registrar's district and sub-district as aforesaid provision should be made for their union with the Superintendent Registrar's district of Castle Ward and with the Gosforth sub-district respectively;

And whereas it is necessary to transfer the functions under the Registration Acts in relation to the part of the Superintendent Registrar's district of Newcastle-upon-Tyne which is situate without the County Borough of Newcastle-upon-Tyne;

Now, therefore, the Registrar-General of Births, Deaths and Marriages in England in exercise of the powers conferred by Sections 10 and 11 of the Births and Deaths Registration Act, 1837, Section 21 of the Births and Deaths Registration Act, 1874, Section 21 (2) of the Local Government Act, 1929, and of all other powers in that behalf, with the approval and sanction of the Minister of Health, hereby orders as follows:—

1.—(1) This Order may be cited as the Newcastle-upon-Tyne and Northumberland Registration of Births, etc., Order, 1935, and shall come in operation on the 1st day of January, 1936.

(2) In this Order the term "district" means a Superintendent Registrar's district, and the terms "existing district" and "existing sub-district" mean a district or sub-district which existed immediately before the 1st day of January, 1936.

2. That portion of the existing Newcastle-upon-Tyne district, namely, the Moot Hall and Precincts, which will on the 1st day of January, 1936, become a separate district and sub-district situate wholly without the County Borough of Newcastle-upon-Tyne shall be united with the Castle Ward district into one district which shall be called the Castle Ward district, and shall be added to and form part of the Gosforth sub-district.

3. The Superintendent Registrar of the existing Castle Ward district shall be the Superintendent Registrar of that district as extended by this Order.

4. The Registrar of the existing Gosforth sub-district shall be the Registrar of that sub-district as extended by this Order.

5. The functions under the Registration Acts in relation to the part of the existing Newcastle-upon-Tyne district which is situate without the County Borough of Newcastle-upon-Tyne are hereby transferred to the Council of the Administrative County of Northumberland.
