URBAN DISTRICT OF BILLINGE-AND-WINSTANLEY.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an order dated the third day of December, 1935, the Minister of Health has declared that, on and after the twenty-third day of December, 1935, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Urban District of Billinge-and-Winstanley, namely:— Sections 39, 40, 41 and 42 (provision and conversion of closet accommodation) comprised in Part III of the Public Health Acts Amendment Act, 1907.

A copy of the order may be inspected at the Council Offices, Billinge, between the hours of 9 a.m. and 5 p.m. on each week-day except Saturday, and on Saturday between 9 a.m. and 12 noon.
