# ROAD TRAFFIC ACT, 1930.

NOTICE is hereby given that on the 4th December, 1935, the Minister of Transport modified and confirmed the Urban District Council of Bebington Roads (Restriction) Order, 1934, made by the Urban District Council of Bebington under Section 46(1) of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933.

The Order as modified provides that:---(1) Subject to certain exceptions, no person shall drive or cause to be driven any heavy locomotive, light locomotive, motor tractor, or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930), or any motor car with seats for more than seven persons exclusive of the driver on the roads specified in the First Schedule hereto. (2) Subject to certain exceptions, no person shall drive or cause to be driven any vehicle on the road specified in the Second Schedule hereto.

Poulton Road from its junction with classified road B.5137 to its junction with Dibbinsdale Road and Poulton Hall Road.

NOTICE is hereby given that on the 29th November, 1935, the Minister of Transport modified and confirmed the County of Devon Roads (Restriction) (No. 1) Order, 1935, made by the Devon County Council under Section 46 of the Road Traffic Act, 1930, and Section 29 of the Road and Rail Traffic Act, 1933.

The Order as modified provides that :--

I.—Subject to certain exceptions, no person shall drive or cause to be driven on the road specified in the First Schedule hereto any heavy locomotive, light locomotive, motor tractor, or heavy motor car (as respectively defined in Section 2 of the Road Traffic Act, 1930), or any motor car with seats for more than fourteen persons exclusive of the driver. II.—No person shall drive or cause to be driven any vehicle on any road specified in the first column of the Second Schedule hereto otherwise than in the direction specified opposite to such road in the second column of that Schedule.
