hundred and twenty-three pounds or there-The Parish Church of St. Lawrence Taynton contains Three hundred sittings.

"3. The said Parish of Taynton includes the District of May Hill which is contiguous to the said Parish of Huntley and is delineated and coloured pink on the plan annexed to the Scheme appended to this Representation and containing an estimated present population of Two hundred or thereabouts. The centre of Two hundred or thereabouts. the said District of May Hill is about one mile distant from the Parish Church of St. John the Baptist Huntley aforesaid and about three miles distant from the Parish Church of There is a St. Lawrence Taynton aforesaid. Mission Church situated in the said District of May Hill which contains Eighty sittings.
"4. It appears to us that under the pro-

visions of the said Pluralities Act the said District known as May Hill may be advantageously separated from the said Rectory of Taynton and annexed to the said Rectory of

Huntley.
"5. The Rectory of Huntley is in the Patronage of Charles Penrhyn Ackers Esquire, J.P., of Huntley Manor. The Rectory of Taynton is in the Patronage of the Dean and

Chapter of Gloucester Cathedral.
"6. The Reverend Joseph Walter Thackwell Master of Arts is the present Incumbent of the Rectory of Huntley. The Reverend Henry Herrick Master of Arts is the present Incumbent of the Rectory of

Taynton.

7. Pursuant to the directions contained in the Twenty-sixth Section of the said Pluralities Act we the said Bishop have drawn up a Scheme in writing annexed to this Representation describing the portion of the said Rectory of Taynton proposed to be annexed to the said Rectory of Huntley and the mode in which it appears to us the alterations may be best effected and how the changes consequent thereon in respect of ecclesiastical jurisdiction glebe lands Tithes rent-charges and other ecclesiastical dues rates and payments and in respect to Patronage and rights to pews may be made with justice to all parties interested and we do hereby submit the same to your Grace together with the Consents in writing of the said Patrons and Incumbents to the intent that if your Grace shall on full consideration and enquiry be satisfied with such Scheme you may certify the same and such Consents aforesaid to His Majesty in Consents Council."

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows:-

" SCHEME.

" It is proposed:-

"That the portion of the Rectory of Taynton known as the District of May Hill delineated and described in the plan hereunto annexed and thereon coloured pink shall be separated from the said Rectory of Taynton and annexed for Ecclesiastical purposes to the Rectory of

"That the Incumbent of the said Rectory of Huntley to which the said portion of the Rectory of Taynton shall be annexed shall have the sole and exclusive cure of souls therein.

"That the Parishioners of the said portion of the said Rectory of Taynton shall be entitled

to accommodation in the Church of the said Parish of Huntley but shall cease to be entitled to accommodation in the Church of the said Parish of Taynton excepting nevertheless any person or persons possessing the legal right by faculty or otherwise to any pew or sitting in the said Church of Taynton and who may not be willing to relinquish and give

up the same.
"That the Mission Church situate in the said District of May Hill shall be transferred to the Parish of Huntley and the Incumbent of the said Parish of Huntley shall have the sole charge of the said Mission Church.

"That the inhabitants of the aforesaid portion shall have such and the same right to have marriages baptisms churchings and burials solemnised and performed in the Parish Church of Huntley as but for the said separation they might have had in the Parish

Church of Taynton.

"That all fees dues and ecclesiastical offerings arising from the said portion of the said Rectory of Taynton so as aforesaid to be annexed to the said Rectory of Huntley shall belong to the Incumbent of the said Rectory of Huntley who shall have all such rights and remedies for enforcing payment of the same as are now or would in the future but for the said separation be exercisable by the Incumbent of the Benefice of Taynton but no portion of the endowments and emoluments (e.g. Tithe rent-charges) other than the sum of Fifty pounds per annum hereinafter referred to shall be transferred.

"That no alterations shall be made in the Patronage of the said Benefices or either of

"That the sum of Fifty pounds per annum forming part of the endowments and emoluments of the said Rectory of Taynton shall be transferred and annexed to the said Rectory of Huntley.

" Consents.

"I, Charles Penrhyn Ackers of Huntley Manor in the County and Diocese of Gloucester being the Patron of or the person entitled to present to the Rectory of Huntley (in case the same were now vacant) the Reverend Joseph Walter John Thackwell the Incumbent of the same Benefice we the Dean and Chapter of the Cathedral Church of Gloucester being the Patrons of or the persons entitled to present to the Rectory of Taynton (in case the same were now vacant) and the Reverend Henry Herrick the Incumbent of the same Benefice do hereby respectively signify to your Grace our several consents to the Scheme above proposed and set forth and to every matter and thing therein contained.
