The following Statute made by the Governing Body of Corpus Christi College, in the University of Oxford, on the 11th day of December, 1935, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

PROPOSED AMENDMENTS TO STATUTES OF THE COLLEGE I.2. (a), III.1. (d) and III.7. (l).

I. In Statute I.2. (a) delete "Junior Research".

II. In Statute III.1. (d), after "capacity for original research", add "A Junior Research Fellow shall not be a member of the Governing Body".

III. Substitute for Statute III.7. (l), the following:—

"For every period of ten years service, a Tutor may apply for leave of absence, to be granted when and as the College may find convenient. Such leave may either be granted for a year (or less) immediately after a ten years period of service, or at an earlier date, provided that in the latter case

(a) the total period of leave shall not exceed two terms in each period of ten years service;

(b) no leave shall be granted until a Tutor has served the College for four years;

(c) leave shall not be granted for more than one term until a Tutor has served the College for seven years;

(d) if leave is taken in two periods of a term each, not less than three years service shall elapse between each period of leave.

If absent for two terms or less, a Tutor shall receive the whole of his emoluments for the period; if absent for a year, he shall receive two-thirds of his annual emoluments.

Any increase this privilege may involve in the tutorial expenses of the College shall be defrayed out of Corporate Revenue."

Given under our Common Seal this eleventh day of December in the year of our Lord one thousand nine hundred and thirty-five.

By virtue of an Act passed in the 24th year of the Reign of His Majesty King George III, intituled "An Act to repeal so much of two Acts made in the 10th and 15th years of the Reign of His present Majesty, as authorizes The Speaker of the House of Commons to issue his Warrant to the Clerk of the Crown for making out Writs for the Election of Members to serve in Parliament in the manner therein mentioned, and for substituting other provisions for the like purposes," And of an Act passed in the 26th year of the Reign of Her Majesty Queen Victoria intituled "An Act to further limit and define the time for proceeding to Election during the Recess."

I do hereby give notice, That the Death of Archibald Noel Skelton, Esquire, late a Member serving in this present Parliament for the University of St. Andrews, the University of Glasgow, the University of Aberdeen, and the University of Edinburgh hath been certified to me in writing under the Hands of Two Members serving in this present Parliament and that I shall issue my Warrant to the Clerk of the Crown to make out a New Writ for the Electing of a Member to serve in this present Parliament for the said Scottish Universities at the end of Six days after the insertion of this Notice in the London Gazette.
