FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1935 (No. 45).

Subject.

Adjusts the boundary of the Wiltshire Footand-Mouth Disease Infected Area as Scheduled in the Order No. 5378, dated 24th December, 1935, by omitting such portions of the parishes of Alkington, Cam and Coaley in the county of Gloucester as lie to the west of the main road from Bristol to Gloucester and also such portion of that road as forms the boundary of the above-named Infected Area.

MINISTRY OF AGRICULTURE AND FISHERIES.

Property Acts, 1922 and 1924.

Whereas sub-section (1) of Section 138 of the Law of Property Act, 1922, provides for the extinguishment of manorial incidents upon the happening of any of the following events:

(a) Where an agreement in writing between the lord and the tenant of the land, or other persons authorised to effect agreements in this behalf, as to the compensation for the extinguishment is made within ten years from the 1st January, 1926, then upon the execution of the agreement;

(b) Where a notice requiring the ascertainment of such compensation is served by the lord on the tenant or by the tenant on the lord within ten years from the 1st January, 1926, then upon service of the notice;

(c) Where no such agreement has been made or notice served before the expiration of ten years from the 1st January, 1926, then upon the expiration of those ten years;

And whereas application has been made to the Minister of Agriculture and Fisheries by the lords of the Honor of Clitheroe in the county of Lancaster (wherein are included the Manor of Chatburn, Worston and Pendleton, the Manor of Accrington New Hold, the Manor of Accrington Old Hold, the Manor of Tottington, the Manor of Ightenhill, the Manor of Colne, the Forest of Trawden, the Forest of Pendle and the Wapentake of Blackburn) for an Order under proviso (ii) to the said sub-section, extending, in the case of the said Honor, for four years the period of ten years referred to in the said sub-section;

And whereas there are in the said Honor not less than one thousand tenants holding land

affected by manorial incidents;

And whereas the Minister having duly considered the said application and having made all necessary enquiries has decided that the desired extension of the said period of ten

years would be expedient;

Now, therefore, the said Minister in exercise of the powers conferred on him by the Property Acts, 1922 and 1924, for the purposes of the extinguishment of manorial incidents in the said Honor of Clitheroe hereby extends the said period of ten years to the first day of January, Nineteen hundred and forty.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this twenty-eighth day of December, Nineteen hundred and thirty-five.
