(c) In making and packing sugar confectionery at the works of The Venture Manufacturing Co. Ltd., Chase Road, N.W.10, subject to conditions similar to those under (a), and to a condition that transport facilities may be required.

(d) In the manufacture of biscuits, cakes and confectionery at the works of The Weston Biscuit Co. (Slough) Ltd., Buckingham Avenue, Slough, subject to conditions similar to those under (c).
