RURAL DISTRICT OF RUGBY.

THE PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

By an Order dated the thirtieth day of January, 1936, the Minister of Health has declared that, on and after the first day of April, 1936, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Rugby, namely:—

Part V (which relates to Common Lodging Houses).

The above provisions are declared to be in force subject, as regards section 75 to the conditions specified in the Order.
