

provisions of "The Universities of Oxford and Cambridge Act, 1923."

STATUTE amending the Statutes of Lincoln College, Oxford, passed by an unanimous vote at a general meeting of the Governing Body of the College specially summoned for the purpose.

In Cap. VI. substitute for Sect. 5 the following:—

5. (i) The Rector shall enjoy the net income from the Twyford estate whether from property in land or from investments in funds or from any other sources. The Twyford estate includes not only the benefice of Twyford, but also the benefaction given by John Morley, Rector, for the augmentation of the Rector's emoluments.

(ii) The Rector and Fellows shall administer the estate and, after deducting from the income the ten pounds annually due to the College out of the revenue of the benefice, and the stipend assigned by the Rector to the Chaplain of Twyford, and all expenses of management and repairs, and all other liabilities, shall pay to the Rector the remainder.

(iii) The Rector and Fellows shall from the income of the said estate maintain it in good condition and repair and shall not allow dilapidations to accumulate such as would need a special settlement of arrears on a change of Rectors.

(iv) Unless the Rector and Fellows with the Rector's consent order otherwise, the Rector shall occupy the lodgings built for him within the precincts of the College, free of rent, rates, and taxes.

In Cap. II, Section 5, omit the words "and Merton" from the title of the Lincoln and Merton Professor of Classical Archaeology and Art.

#### TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday, the 13th March, 1936, at 1 o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-19, to the amount of £45,000,000.

2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 16th March, 1936, to Saturday, the 21st March, 1936, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the Bank of England.

4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.

7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

9. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
