At the Court at Buckingham Palace, the 3rd day of March, 1936.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 25th day of February, 1936, (C.E. 7233/35), in the words following, viz.:—

"Whereas by the twentieth section of an Act passed in the twenty-ninth year of Her late Majesty's reign, Chapter 89, entitled 'The Greenwich Hospital Act, 1865,' it is, amongst other things, enacted that the Admiralty shall, from time to time continue or appoint such Officers, Clerks and Servants for the purposes of the Hospital and Schools as seem fit, and may (subject to the approval of Your Majesty in Council) fix the salaries of such Officers and Clerks:

"And whereas by Order in Council bearing date the 29th June, 1934, the scale of salary of the Director of Greenwich Hospital was authorised to be at the rate and on the scale of £1,000 to £1,200 a year (plus Civil Service Bonus) rising by £50 a year as from the 13th October, 1934:

"And whereas the scales of salary of similar posts in the Admiralty were revised as from 1st October, 1935:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to authorise the scale of salary of the Director of Greenwich Hospital to be at the rate and on the scale of £1,150 to £1,450 a year inclusive rising by £50 a year as from the 1st October, 1935."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.
