And whereas it is desired that the capital of the Bliss Fund shall be equally divided between St. John Baptist College and Oriel College:

And whereas it appears to us The Provost and Fellows of Oriel College, Oxford, that it is desirable that a new Statute should be made

in manner hereinafter appearing:

We, the said Provost and Fellows of Oriel College do hereby in exercise of the powers vested in us under and by virtue of Section 7 of the Universities of Oxford and Cambridge Act, 1923, alter and add to the Statutes of Oriel College, Oxford, in manner following, that is to say by the addition of a new Statute as follows:—

STATUTE XVIII.

BLISS TRUST.

1. One-half of each of the investments representing the Bliss Fund on the date of the approval of this Statute by His Majesty in Council shall be forthwith transferred (together with one-half of the undistributed income (if any) of the Bliss Fund held by St. John Baptist College at the date of such transfer) by St. John Baptist College to Oriel College and shall be received by Oriel College.

2. As from the date of the said transfer St. John Baptist College shall be released and discharged from the trust to pay over one-half of the income of the Bliss Fund to Oriel College or St. Mary Hall and from all liability what-

soever in respect thereof.

3. Oriel College shall apply the income of their moiety of the Bliss Fund for the maintenance and repair of the College buildings (including the buildings formerly the Principal's lodgings and the Hall buildings of St. Mary Hall).

Ex parte the President and Fellows of Saint John Baptist College in the University of Oxford.

A STATUTE made to amend and to add to certain statutes framed by the Commissioners appointed under the Universities of Oxford and Cambridge Act 1923 (13 and 14 Geo. 5 ch. 33) in relation to Saint John Baptist College in the University of Oxford, duly passed at a General Meeting of the Governing

Body of the said College specially summoned for this purpose on the 22nd day of April, 1936, under Section 7 (2) of the said Act, by the votes of not less than two thirds of the number of the persons present and voting (notice of which has in accordance with Section 7 (2) of the said Act been given to the University of Oxford and which is not a Statute which affects the University of Oxford within the meaning of the said Section) and submitted to His Majesty in Council.

Whereas by his Will dated the 15th day of September, 1856, the Reverend Philip Bliss (hereinafter called the Testator) gave the residue of his estate (hereinafter referred to as the Bliss Fund) after the death of his Wife Sophia Bliss to the President and Fellows of Saint John Baptist College in Oxford in trust to pay over one half of the income arising therefrom to the Principal of St. Mary Hall for the time being year by year in order to create and keep up a fund for the maintenance and repairs of the said Principal's lodgings and the Hall buildings more especially for the painting of the said lodgings and Hall buildings and to pay the other half of the said income towards the augmentation of the Librarian's place of the said College of Saint John Baptist on the conditions therein mentioned:

And whereas the Testator died on the 18th day of November, 1857, without having revoked or altered his said Will except by a Codicil dated the 17th day of June, 1857, which did not affect the provisions of the residuary gift hereinbefore recited:

And whereas the said Will (with the said Codicil) was proved in the Prerogative Court of Canterbury on the 9th day of January, 1858, by the said Sophia Bliss the sole Executrix named in the said Will:

And whereas the said Sophia Bliss died on the 16th day of February, 1876:

And whereas under and by virtue of a Statute made by the University of Oxford Commissioners under the Universities of Oxford and Cambridge Act, 1877, on the 16th day of June, 1881, and approved by the Queen in Council on the 3rd day of May, 1882, and in the events which have happened St. Mary Hall became completely united to Oriel College in the year 1902:

And whereas no provisions were contained in the said Statute or in any other Statute made for Oriel College or St. Mary Hall as to the application of the income of the Bliss Fund after the said Union of Oriel College and St. Mary Hall:
