and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, duly prepared, and laid before His Majesty in Council, a Representation, bearing date the 14th day of May, 1936, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 59th year of His late Majesty King George the Third, Chapter 134, of the Act of the 2nd and 3rd years of Her late Majesty Queen Victoria, Chapter 49, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 55, have prepared, and now humbly lay before Your Majesty in Council, the following Representation as to the assignment of a District Chapelry to the consecrated Church of Saint Bartholomew, situate at Herne Bay, in the Parish of Herne, in the County of Kent, and in the Diocese of Canterbury:

"Whereas it appears to us to be expedient that a District Chapelry should be assigned to the said Church of Saint Bartholomew, situate at Herne Bay as aforesaid:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, Archbishop of Canterbury (testified by his having signed and sealed this Representation), we, the said Ecclesiastical Commissioners, humbly represent, that it would, in our opinion, be expedient that all that part of the said Parish of Herne which is described in the Schedule hereunder written, all which part, together with the boundaries thereof, is delineated and set forth on the map or plan hereunto annexed, should be assigned as a District Chapelry to the said Church of Saint Bartholomew, situate at Herne. Bay as aforesaid and that the same should be named 'The District Chapelry of Saint Bartholomew, Herne Bay '.

"And with the like consent of the said Cosmo Gordon, Archbishop of Canterbury (testified as aforesaid), we, the said Ecclesiastical Commissioners, further represent, that it appears to us to be expedient that banns of matrimony should be published, and that marriages, baptisms, churchings, and burials should be solemnized or performed at the said Church of Saint Bartholomew, situate at Herne Bay as aforesaid, and that the fees or dues to be received in respect of the publication of banns and of the solemnization or performance of marriages, churchings and burials should be paid and belong to the Minister of the same church for the time being.

"THE SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Bartholomew, Herne Bay, being:-

"All that part of the Parish of Herne, in the County of Kent and in the Diocese of Canterbury, which is bounded upon the east by the Parish of Reculver, in the said County and Diocese, upon the north by the sea, upon the west by the New Parish of Christ Church, Herne Bay, in the said County and Diocese, and upon the remaining side, that is to say, upon the south, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, Herne Bay,

from the said Parish of Herne, at the centre of the bridge which carries the Kent Coast Line of the Eastern Section of the Southern Railway across Canterbury Road, and extending thence eastward along the middle of the said line of railway for a distance of 1 mile and 4 chains or thereabouts to a point in the middle of Bogshole Bridge upon the boundary which divides the said Parish of Herne from the said Parish of Reculver."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Canterbury.
