NUNEATON GAS.

(Application for an Order under Section 1 of the Gas Undertakings Act 1929.)

NOTICE is hereby given that the Nuneaton Gas Company (hereinafter referred to as "the Company") whose address is Queens Road, Nuneaton, intend to apply to the Board of Trade for an Order under Section 1 of the Gas Undertakings Act, 1929, for the following purposes, that is to say:—

1. To authorise the Company to raise, at any time during the period of three years after the date on which the Order comes into operation, additional share capital of an amount not exceeding £25,000.

2. To modify the provisions of section 20 of the Nuneaton Gas Act 1886 and section 7 of the Nuneaton Gas Order 1901 (confirmed by the Gas Orders Confirmation Act 1901) and to repeal or amend any other provisions of the Nuneaton Gas Acts and Orders 1886 to 1931 and any other Act or Order affecting the Company which may be necessary in order to give full effect to the proposed Order.

Any local or other public authority, company or person desiring to bring before the Board of Trade any objection to the application may do so by registered letter addressed to the Director of Gas Administration, Board of Trade, Great George Street, S.W.1, and despatched on or before the 29th day of July, 1936.

Any such objection must state the specific grounds of objection and a copy of the objection must be forwarded to the undermentioned Parliamentary Agents at the same time as it is sent to the Board of Trade.
