

distance of 5 chains or thereabouts to the point where it reaches the northern bank of the River Aire, and extending thence first south-westward to and then north-westward along the middle of the River Aire for a distance of 28 chains or thereabouts to the boundary which divides the said District Parish of Saint Stephen, Kirkstall, from the said Parish or Parochial Chapelry of Bramley.

"2. And also all that contiguous portion of the said New Parish of Woodside which is bounded upon the south-west, upon the south and upon the south-east by the above described portion of the said District Parish of Saint Stephen, Kirkstall, and upon the remaining sides, that is to say, upon the north and upon the north-west, by an imaginary line commencing at the point where the boundary which divides the said District Parish of St. Stephen, Kirkstall, from the said New Parish of Woodside diverges southward from following the middle of Butchers Hill, and extending thence first westward and then north-westward along the middle of Butchers Hill for a distance of 13 chains or thereabouts to the centre of the bridge which carries it across Oil Mill Beck, and extending thence south-westward along the middle of Oil Mill Beck for a distance of 3 chains or thereabouts to the boundary which divides the said New Parish of Woodside from the said District Parish of Saint Stephen, Kirkstall."

And whereas the said Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Ripon.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council, a Scheme bearing date the 25th day of June, 1936, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the unions (1) of the Benefice (being a Rectory) of Dalham with the Benefice of Gazeley (now part of the United Benefice of Gazeley with Kentford) and (2) the Benefice (being a Vicarage) of Higham Green, Saint Stephen, with the Benefice of Kentford (now part of the said United Benefice of Gazeley with Kentford) all

of which Benefices are situate in the County of Suffolk and in the Diocese of Saint Edmundsbury and Ipswich:

"Whereas Commissioners appointed at our request by the Right Reverend Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the unions (1) of the said Benefices of Dalham and Gazeley and (2) of the said Benefices of Higham Green, Saint Stephen, and Kentford, duly made their Report to the said Bishop of Saint Edmundsbury and Ipswich and therein recommended the said unions of Benefices and the terms for effecting the same, and the said Bishop of Saint Edmundsbury and Ipswich signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the said unions of Benefices based upon the terms recommended in the said Report:

"And whereas the said United Benefice of Gazeley with Kentford and the said Benefice of Higham Green, Saint Stephen, are now full the Reverend Canon Richard Albert Thomas being the present Incumbent of the said United Benefice of Gazeley with Kentford and the Reverend Fred Eley being the present Incumbent of the said Benefice of Higham Green, Saint Stephen, and the said Benefice of Dalham is at present vacant:

"Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consents of the said Walter Godfrey, Bishop of Saint Edmundsbury and Ipswich, the said Richard Albert Thomas and the said Fred Eley (testified by their respectively signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

"1. That the said Benefice of Dalham and the part of the said United Benefice of Gazeley with Kentford which consists of the said Benefice of Gazeley shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Gazeley with Dalham' but the Parishes of the said Benefices shall continue distinct in all respects.

"2. That the said Benefice of Higham Green, Saint Stephen, and the part of the said United Benefice of Gazeley with Kentford which consists of the said Benefice of Kentford shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Kentford with Higham Green' but the Parishes of the said Benefices shall continue distinct in all respects.

"3. That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the said unions shall forthwith take effect and the said Richard Albert Thomas if he is then Incumbent of the said United Benefice of Gazeley with Kentford shall become the first Incumbent of the United Benefice of Gazeley with Dalham and the said Fred Eley if he is then Incumbent of the said Benefice of Higham Green, Saint Stephen, shall become the first Incumbent of the United Benefice of Kentford with Higham Green.

"4. That upon the said unions taking effect (1) the Parsnage House at present belonging
