## BOROUGH OF BRENTFORD AND CHISWICK.

### TOWN AND COUNTRY PLANNING ACT, 1932.

#### BRENTFORD AND CHISWICK TOWN PLANNING SCHEME "A."

NOTICE is hereby given that (1) on the eleventh day of July, one thousand nine hundred and thirty-six, the Minister of Health notified his approval of the resolution of the Town Council of the Borough of Brentford and Chiswick, dated the 29th day of April, 1936, deciding to prepare the above planning scheme with reference to an area situate within the Borough of Brentford and Chiswick; (2) the map defining the area to which the resolution applies has been deposited at the Town Hall, Chiswick, and will be open for inspection by all persons interested without charge between the hours of 10 a.m. and 12.30 p.m., and 2.30 p.m. and 4.30 p.m. on week days (Saturdays 10 a.m. and 12 noon); (3) any person who is, or claims to be, an owner of any property in the area and any association representing owners of property within the Borough of Brentford and Chiswick, and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Town Council of the Borough of Brentford and Chiswick to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933, the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Town Council of the Borough of Brentford and Chiswick are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid map.

The Town Council intend to proceed as soon as may be with the preparation of a Draft Scheme, and any suggestions as to the proposals to be included therein should be sent in writing to the Town Clerk.
