RULES PUBLICATION ACT, 1893.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiration of at least 40 days from this date in pursuance of the powers conferred upon him by Section 10 of the London Traffic Act, 1924, to make the London Traffic (Prescribed Routes) (No.) (Kingsbury) Regulations, 1936, in regard to a scheme of "one-way" traffic working in the service road in Kingsbury Road (A.4006) at the junction of Kingsbury Road with Kingsbury Circus, Kingsbury, Middlesex.

ROAD TRAFFIC ACT, 1930.

COUNTY OF DEVON.

Notice is hereby given that on the 17th September, 1936, the Minister of Transport made an Order under Section 46 (3) of the Road Traffic Act, 1930, further amending an Order dated 2nd August, 1924, and made under Section 7 (4) of the Roads Act, 1920, which restricted the use of certain mechanically propelled vehicles upon various highways in the County of Devon.

The effect of the amending Order is to remove the restrictions on the use of the road between Yennadon New Road and Prowse's Crossing in the Rural District of Tavistock.

MINISTRY OF AGRICULTURE AND FISHERIES.

DESTRUCTIVE INSECTS AND PESTS ACTS, 1877 TO 1927.

Notice is hereby given in pursuance of Section 5 of the Destructive Insects Acts, 1877, that the Minister of Agriculture and Fisheries has made the following Orders:—

Order No. D.I.P. 591 (dated 21st August, 1936) Fruit Tree Pests (East Hampshire) Order of 1936;

Order No. D.I.P. 592 (dated 4th September, 1936) Fruit Tree Pests (West Sussex) Order of 1936.

These Orders empower officers appointed by the Local Authorities for the Administrative Counties of Southampton and West Sussex, respectively, to investigate complaints from fruit growers that fruit trees growing on other premises are likely to cause the spread to their own trees of certain scheduled diseases and pests, and enable the Local Authorities to take action to prevent the spread of infection.

Order No. D.I.P. 591 is operative only within certain parishes in the Petty Sessional Divisions of Alton and Petersfield in the Administrative County of Southampton;

Order No. D.I.P. 592 is operative within the Administrative County of West Sussex, and the Borough of Worthing.
