MORECAMBE AND HEYSHAM.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Morecambe and Heysham (hereinafter called the Corporation) have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or

amend the Morecambe Corporation Act, 1924, and the Morecambe Corporation Act, 1928, so as:—

(1) To provide that the provisions of Section 116 of the said Local Act of 1924 shall apply, in addition to the streets and places mentioned in that Section or in Section 81 of the said Local Act of 1928, in or on any esplanade, parade, public walk, garden, open space, place of recreation, or in or on any place in any street within fifty yards from the promenade, Marine Road, or the promenades authorised by the said Local Act of 1928;

(2) To extend the provisions of Section 116 of the said Local Act of 1924 so as to prohibit, without the consent in writing of the Corporation, of the taking of any photograph of any person or group of persons by way of trade or business, in or on any of the streets and places mentioned in the Sections above referred to as proposed to be amended;

(3) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Acts, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application;

Notice is hereby given that C. J. Maslin, Esq., O.B.E., one of the Inspectors of the Ministry of Health will attend at the Town Hall, Morecambe and Heysham on Monday the thirtieth day of November, 1936, at three o'clock in the afternoon, to hold a Local Inquiry into the subject-matter of the said Application and the proposed Provisional Order.

And notice is hereby further given that any person interested may attend at such Inquiry and be heard with reference to the said Application and the proposed Provisional Order.
