STATUTE APPROVED BY CONGREGATION ON
TUESDAY 3 NOVEMBER, 1936.

WHEREAS it is expedient that the provisions of the Statute governing Elections to Professorships should apply to University Lecturerships which are required by Statute to be filled up when vacant:

Now the University of Oxford, in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all other powers enabling it, enacts, subject to the approval of His Majesty in Council, as follows:—

In *Statt. Tit. IV. Sect. 1. § 2 (a). cl. 8 (Statuta, 1936, p. 51, line 39)* the words "or Lecturership" shall be inserted after "Readership".
