UCKFIELD ELECTRICITY.

(Increase of capital and borrowing powers of the Uckfield Gas and Electricity Company and matters in connection therewith.)

APPLICATION has been made by the Uckfield Gas and Electricity Company (hereinafter called "the Applicants") whose principal office is situate at 424, Salisbury House, London Wall, in the City of London, to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1936 and the Statutory Gas Companies (Electricity Supply Powers) Act 1925 for a Special Order for the following objects:—

1. To authorise the Applicants to raise additional capital for their electricity under-

taking by the creation and issue of additional electricity ordinary stock.

2. To increase the borrowing powers of the Applicants and to authorise the Applicants to create and issue debenture stock (redeemable or otherwise).

3. To make provision with respect to the offer of stock for public subscription, the payment of commission, the sale of stock by auction or tender, and other financial matters, and to extend and apply certain provisions of the Uckfield Gas and Electricity Act 1925.
