acts as may be proper for storing gas and for supplying gas within the limits of supply, and also (except on the lands hereinafter described in paragraphs 5 and 6) for making gas, and (except as aforesaid) to work up and convert the residual products of gas. The lands above referred to are:—

- 1. Land in the parish of Madeley in the county of Salop comprising 1.75 acres or thereabouts and being bounded on the north as to part by land belonging to or reputed to belong to John Wilkes as to part by the highway known as Madeley Hill as to part by land belonging or reputed to belong to Bernard Maddox as to part by land belonging or reputed to belong to William Harris and as to the remainder by land belonging or reputed to belong to John Harris on the east by land known as the Iron Bridge Recreation Ground and belonging or reputed to belong to the Corporation of Wenlock on the south by a private road running approximately parallel with and to the north of the highway known as Coalport Road and on the west by a footpath leading from the said private road to Madeley Hill aforesaid.
- 2. Land in the said parish of Madeley in the county of Salop comprising .75 acres or thereabouts and being bounded on the north as to part by the said highway known as Madeley Hill as to the remainder by a footpath leading from the said highway to the south-western corner of the land described in the last preceding paragraph hereof on the east as to part by the said footpath and as to the remainder by waste land adjoining the same on the south by a road way leading from the Iron Bridge Drill Hall to the southern end of the said footpath on the west by the said Iron Bridge Drill Hall and adjoining land belonging or reputed to belong to Shropshire Territorial Force Association.
- 3. Land in the parish of Broseley in the county of Salop containing '756 acres or thereabouts and comprising a part of enclosure numbered 26 and a part of enclosure numbered 27 on the ordnance sheet Shropshire XLIII. 14 (1927 Edition) which land is bounded on the north by land adjoining or forming part of the bank of the River Severn on the east by enclosure numbered 32 on the said ordnance sheet on the south by land forming a part of the Great Western Railway and on the west by other land comprised in the said enclosures numbered 26 and 27 on the said ordnance sheet.
- 4. Land in the parish of Dawley in the urban district of Dawley in the county of Salop containing '929 acres or thereabouts and being enclosure numbered 607 on the ordnance sheet Shropshire XLIII. 6 (1927 Edition) which land is bounded on the northwest by a roadway numbered 606 on the said ordnance sheet on the east by enclosure numbered 604 on the said ordnance sheet and on the south as to part by enclosure numbered 608 and as to the remainder by enclosure numbered 610 on the said ordnance sheet.
- 5. Land in the parish of Madeley in the county of Salop comprising 335 acres or thereabouts and numbered 196 on the

ordnance sheet Shropshire XLIII. 11 (1927 Edition) which land is bounded on the north by a highway known as Queen Street and formerly known as Hills Lane on the east by the towing path of the London Midland and Scottish Railway Company's Canal on the south in part by the land next hereinafter described and in part by other land comprised in enclosure numbered 722 on the said ordnance sheet and on the north-west by other land adjoining Queen Street aforesaid.

- 6. Land in the parish of Madeley in the county of Salop comprising 150 square yards or thereabouts and being a part of the enclosure numbered 722 on the ordnance sheet Shropshire XLIII. 15 (1927 Edition) which land is bounded on the north by the land hereinbefore described on the east by the said towing path of the London Midland and Scottish Railway Company's Canal and on the west and south by the remainder of the said enclosure numbered 722.
- 18. To empower the Company to purchase lands by agreement, to sell and lease lands, to lay pipes in private streets, to lay pipes and wires for ancillary purposes, and to provide dwellinghouses for employees, offices and showrooms.
- 19. To empower the Company to put in force a profit-sharing scheme to enable the employees to participate in the profits of the undertaking and to make provision for the disposal of stock and deposits of co-partners on death.
- 20. To provide that gas fittings supplied on hire by the Company shall not be subject to distress and shall remain the property of the Company although attached to the premises, to enable the Company to make charges for special readings of meters and to relieve the Company from obligation to supply in certain cases.
- 21. To make provision for the prevention of improper use of gas, the position of gas meters and the inspection and testing of gas meters.
- 22. To empower the Company to contract with any person for the supply by the Company to him or to the Company by him of gas in bulk.
- 23. To make provision as to the authentication and service of notices by the Company and as to the form and service of notices to the Company for the discontinuance of a supply of gas.
- 24. To make provision as to the recovery summarily of sums due for fittings and as to the recovery of penalties, and of other sums due to the Company and to provide for the inclusion of several sums in one summons.

25. To make provision as to arbitrations and for the costs and expenses of the intended Order and for a copy thereof to be registered.

26. To confer upon the Company all or any powers commonly conferred upon gas undertakers and not hereinbefore referred to and to vary or extinguish all rights and privileges which would impede or interfere with its purposes and to confer other rights and privileges.

27. To incorporate with the Order, with or without modification, all or some of the provisions of the Land Clauses Acts, the Gasworks Clauses Act, 1847, and the Gasworks Clauses Act, 1871.
