

forming part of the Rural District of Northwich and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the Mid-Cheshire No. 1 Regional Planning Committee to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,\* the development of land in the area during the preparation of the scheme is permitted to the extent specified in the Order and in addition the Chester Rural District Council in respect of the several parishes situate within the Rural District hereinbefore referred to; the Nantwich Rural District Council in respect of the several parishes situate within the Rural District hereinbefore referred to; the Tarvin Rural District Council in respect of the several parishes situate within the Rural District hereinbefore referred to; the Nantwich Urban District Council in respect of the part of the Urban District hereinbefore referred to; and the Northwich Rural District Council in respect of the several parishes situate within the Rural District hereinbefore referred to; are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The Mid-Cheshire (Area No. 2) Joint Town Planning Committee intend to proceed as soon

as may be with the preparation of a Draft Scheme for the area to which the resolution applies except in so far as it relates to the part of the parishes of Baddington and Austerson and the parishes of Utkinton, Rushton, and Tarporley situate within the Urban District of Nantwich and the Rural District of Northwich respectively, and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Clerk to the Mid-Cheshire (Area No. 2) Joint Town Planning Committee.

The Mid-Cheshire No. 1 Regional Planning Committee intend to proceed with the preparation of a Draft Scheme for the parts of the parishes of Baddington and Austerson now situate within the Urban District of Nantwich and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Clerk to the Mid-Cheshire Regional Planning Committee, Town Clerk's Office, Municipal Buildings, Earle Street, Crewe.

The Mid-Cheshire No. 3 Regional Planning Committee intend to proceed as soon as may be with the preparation of a Draft Scheme for the parishes of Utkinton, Rushton, and Tarporley now situate within the Rural District of Northwich, and any suggestions as to the proposals to be included in the Draft Scheme should be sent in writing to the Clerk to the Regional Committee, 20, Winnington Street, Northwich.
