LAND DRAINAGE ACT, 1930.

*Kent Rivers Catchment Area.*

*Kent Rivers Catchment Board.*

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the Order made on the 30th day of November, 1936, combining, as from a day to be appointed by the Minister, the River Medway, the North Kent Rivers, the Romney and Denge Marsh Main Drains, and the River Stour (Kent) Catchment Areas as one Catchment Area, which shall be known as the Kent Rivers Catchment Area and constituting a Catchment Board for the combined areas to be known as the Kent Rivers Catchment Board, which Order has now come into force.

A copy of the Order may be seen at all reasonable hours at the Offices of the Ministry of Agriculture and Fisheries, 10, Whitehall Place, London, S.W.1, and at the Office of the Clerk of the Kent County Council, Sessions House, Maidstone.

By Part III of the Second Schedule to the said Act, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this Notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

*East Norfolk Rivers (including the River Waveney) Catchment Board.*

*Happisburgh to Winterton Internal Drainage Board.*
