The Secretary for Mines has appointed Mr. William Brown to be a Junior Inspector of Mines under the Coal Mines Acts, 1887 to 1919, and has instructed him to act also as an Inspector for the purposes of the Metalliferous Mines Regulation Acts, 1872 and 1875, and of the Quarries Act, 1894.

Under the provisions of the Mining Industry Act, 1920, and of the Factory and Workshop Act, 1901, the Secretary for Mines has further appointed Mr. Brown to be an Inspector of Factories and Workshops for the purposes of the Factory and Workshop Act, 1901, so far as it applies to quarries and pitbanks as defined in Part II of the Sixth Schedule to that Act.

### PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of Section 2 (3) of the Petroleum (Production) Act, 1934, the Board of Trade hereby give notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, they have granted to the D'Arcy Exploration Company, Limited, of Britannic House, Finsbury Circus, London, E.C.2, Prospecting Licences in respect of the areas contained in the First Schedule hereto. They have also granted an application by the same Company for the extension of two licensed areas previously granted to them, so as to embrace the additional lands contained in the Second Schedule hereto.
