### XXXIII.

At least one Exhibition shall be awarded every year in each of the main branches of study should a worthy candidate be forthcoming.

## XXXIV.

For the purposes of these Statutes the expression "the main branches of study" in the preceding Statute shall be taken to mean Classics, Mathematics, Natural Science, Modern Languages and Modern History.

# XXXV.

Two, but not more than two, Exhibitions may be held together, provided they are not awarded in the same main branch of study.

#### XXXVI.

If two candidates are equal in the competition for an Exhibition in any one subject, preference may be given to the candidate who stands highest in the General Examination, or the Exhibition may be divided.

## XXXVII.

Every Exhibition shall be tenable for four years, reckoning from the Michaelmas next after the election, provided that the holder leave the School on being so elected and read for Honours at any University in the United Kingdom, or, subject to the approval of the Governing Body, pursue other studies at such a University or elsewhere. Provided also that, before the payment of each instalment of the Exhibition, the holder produce such certificates as the Governing Body shall require of his good conduct and his diligence in study. Provided, further, that the Governing Body shall have power to deprive of his Exhibition any Exhibitioner who shall in their opinion have been proved guilty of lack of industry or of serious misconduct.

# TENDERS FOR TREASURY BILLS.

- I. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday, the 12th March, 1937, at I o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £45,000,000.
- 2. The Bills will be in amounts of £5,000 or £10,000. They will be dated at the option of the Tenderer on any business day from Monday, the 15th March, 1937, to Saturday, the 20th March, 1937, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
