READY-MADE AND WHOLESALE BESPOKE TAILORING TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Ready-made and Wholesale Bespoke Tailoring Trade Board (Great Britain) hereby give notice that they propose to vary minimum rates of wages for male and female workers at present set out in the Schedule to their Notice R.M.(29) dated 18th December, 1933.

Particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board at the address given below.

In accordance with Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will consider any objection to the proposed variations which may be lodged with them within two months from 12th March, 1937.
