And whereas by an Order in Council of the 2nd February, 1937, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 17th day of March next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish of Langford save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as follows, viz.:—

LANGFORD.—Forthwith and entirely in the Church of Saint Giles, in the said Parish, and in the Old Churchyard attached thereto.

Provided that—

(a) In the vault now existing in the said churchyard, in which the remains of Mary Jane Byron are interred, the burial may be allowed at their decease of the bodies of Frederick Ernest Charles, Lord Byron, and Anna Ismay Ethel, Lady Byron, subject to the condition that each coffin buried in such vault be separately enclosed by stonework or brickwork properly cemented.

(b) In the earthen graves now existing in the said Churchyard, in which the remains of Lilius Lee Baker and Jeannie Doris Lavender Baker are interred, the burial may be allowed at their decease of the bodies of Mary Rosalind Pye and Natalie Violet Mary Wakelin, subject to the condition that no part of the coffins containing the bodies shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
