## ROAD TRAFFIC ACT, 1930—SECTION 102.

NOTICE is hereby given that the Mayor Aldermen and Burgesses of the County Borough of Rotherham have applied to the Traffic Commissioners for the Yorkshire Area for consent to the running of Public Service Vehicles on the following roads namely:—

From the junction of New Orchard Lane with Woodhouse Green, Green Arbour Road and Sandy Lane in the parish of Thurcroft in the Rural District of Rotherham in the West Riding of the County of York, along New Orchard Lane aforesaid for a distance of 730 yards to Thurcroft Colliery in the said parish and district.

Any objection to the operation of this route by any local authority, County Council or any persons who are already providing transport facilities on, or in the neighbourhood of, the said route may be made to the Traffic Commissioners (Yorkshire Area), 44, The Headrow, Leeds, on or before the 20th day of May 1937.

Any such objection should be in writing and should state clearly the grounds for such objection and a copy thereof should, at the same time, be sent by the objector to the Town Clerk of the said County Borough of Rotherham.

## LANGPORT AND DISTRICT PLANNING SCHEME.

NOTICE is hereby given that (1) On the 27th day of April 1937 the Minister of Health notified his approval of the resolution of the Langport Rural District Council Town Planning Committee dated the 21st day of January 1937 deciding to prepare the above planning scheme with reference to the whole area situate within the Rural District of Langport. (2) A certified copy of the Map defining the area to which the resolution applies has been deposited

at the Council Offices, North Street, Langport, Somerset, and will be open for inspection by all persons interested without charge between the hours of 10 a.m. and 4 p.m., except on Saturdays, when the hours will be from 10 a.m. to 12 (noon). (3) Any person who is, or claims to be an owner of any property in the area and any association representing owners of property within the said Rural District of Langport and any local association representing business or industry may by notice in writing, specifying in the case of an owner the property of which he claims to be the owner, require the said Langport Rural District Council Town Planning Committee to register without charge his or their name and address for the service of subsequent notices relating to the scheme.

Under the Town and Country Planning (General Interim Development) Order, 1933,\* the development of land in the area during the preparation of the Scheme is permitted to the extent specified in the Order and in addition the Langport Rural District Council are empowered to permit other development in the area during this period, with a view in either case to protecting the development from the risk of removal or alteration without compensation under the scheme when approved and in operation. A print of the Order has been deposited together with the aforesaid Map.

The said Langport Rural District Council Town Planning Committee intend to proceed as soon as may be with the preparation of a Draft Scheme and any suggestions as to the proposals to be included in such Draft Scheme should be sent in writing to the Clerk to the Committee.
