(Application for Special Order under the Gas Undertakings Acts, 1920 to 1934.)

THE Pontypool Gas and Water Company (hereinafter called "the Company") whose address is Clarence Street, Pontypool, Mon., are applying to the Board of Trade for a Special Order under the Gas Undertakings Acts, 1920 to 1934, for the following objects:

I. To provide for the sale and transfer to and vesting in the Company of the undertakings of the Blaenavon Gas and Water Company Limited (hereinafter called "the Blaenavon Company") and of the Usk Gas Company Limited (hereinafter called "the Usk Company ") including all lands, hereditaments, easements, works, buildings and other property of whatsoever kind of or belonging to or vested in the Blaenavon Company and the Usk Company except such property or assets (if any) as may be stated in the Order, to prescribe the dates on which the sale transfer and vesting of the said undertakings shall take effect, and to make provision with respect to the carrying on of those undertakings up to those dates.

2. To make provision in consideration of the sale transfer and vesting to and in the Company of the undertaking of the Blaenavon

Company, for the creation and issue to holders of shares of the Blaenavon Company (hereinafter called "Blaenavon shares") of shares of the Company (hereinafter called "Ponty-pool shares") in substitution for Blaenavon shares and to attach to such Pontypool shares such rights powers and privileges as the Order may provide; and to make provision with respect to the dates up to and from which the Blaenavon shares and Pontypool shares shall respectively be entitled to dividend, and with respect to the rates of dividend.

3. To provide for and require the delivery up of the certificates of Blaenavon shares and the issue instead thereof of certificates of Pontypool shares; to make provision as to the consequences of failure to deliver up certificates of Blaenavon shares; to authorise and require trustees, executors and other persons to accept, hold and deal with Pontypool shares as they might have held and dealt with Blaenavon shares; and to provide that references in deeds, wills and other instruments to Blaenavon shares shall be construed as references to Pontypool shares.

4. To prescribe the consideration to be paid by the Company to the Usk Company for the sale transfer and vesting to, and in the Com-pany of the undertaking of the Usk Company.

5. To provide for the charging on the undertaking of the Company of the debentures of the Usk Company and as to the ranking of those debentures and the interest thereon.

6. To make provision with respect to the debts and liabilities of, and monies due or accruing due to, the Blaenavon Company and the Usk Company and the payment and recovery thereof respectively.

7. To provide for the crediting to the appropriate reserved or other fund of the Company of any monies standing to the credit of any reserve or other fund of the Blaenavon Company or of the Usk Company.
