In the rural district of Pontypool:-

The parish of Gwehelog Fawr;

So much of the parish of Llantrisant Fawr as is situate to the north-west of a straight line between the point at which the boundary between that parish and the parish of Llangwm meets the boundary between the parish of Llantrisant Fawr and the parish of Raglan United and the point at which the boundary between the urban district of Usk and the parish of Llantrisant Fawr meets the boundary between the urban district of Usk and the parish of Llanbadoc Fawr.

So much of the parish of Llanbadoc Fawr as is situate to the north-east of a straight line between the point at which the boundary between that parish and the parish of Llangybi Fawr meets the boundary between the parish of Llanbadoc Fawr and the parish of Llantrisant Fawr and the point at which the boundary between the parish of Llanbadoc Fawr and the parish of Goytre Fawr meets the boundary between the parish of Llanbadoc Fawr and the urban district of Pontypool.

So much of the parish of Goytre Fawr as is situate to the south-west of a straight line between the point at which the boundary between that parish and the parish of Gwehelog Fawr meets the boundary between the parish of Goytre Fawr and the parish of Llanbadoc Fawr and the point at which the boundary between the parish of Goytre Fawr and the urban district of Pontypool meets the boundary between the urban district of Pontypool and the urban district of Blaenavon.

So much of the parish of Llanfrechfa Lower as lies to the south of a straight line drawn due west from the southernmost point of the enclosure numbered 474 on the \$\frac{1}{2500}\$ Ordnance Map Edition of 1920 Monmouthshire Sheet XXIX I to the boundary between the said parish and the urban district of Cwmbran.

10. To authorise the Company to hold and use for the purposes of their undertaking the lands hereinafter described and on those lands to maintain, erect, alter, improve, extend, renew and use or discontinue gas works, machinery and other apparatus and to make and store gas and to work up and convert residual products.

The lands above referred to are:

(a) The lands on which the existing gas works of the Blaenavon Company are situate, namely, all those two pieces of land in the urban district of Blaenavon containing in the whole 2,843 square yards or thereabouts bounded on the north-east by the enclosure numbered 437 on the 12500 Ordnance Map Edition of 1920 Monmouthshire Sheet XII 14 on the south-east by the enclosure numbered 438 on the said sheet of the said Ordnance Map on the south-west partly by land belonging or reputed to belong to Mary Thomas and partly by land belonging or reputed to belong to John Henshaw Rees and on the north-west by land belonging or reputed to belong to the trustees of the Will of the late Francis James and occupied by the Blaenavon Company.

- (b) The lands on which the existing gas works of the Usk Company are situate, namely, all that piece of land in the urban district of Usk containing 2,624 square yards or thereabouts bounded on the north-west and north-east by the enclosure numbered 87 on the 2500 Ordnance Map Edition of 1921 Monmouthshire Sheet XIX 15 on the southeast by Four Ash Street and on the southwest by land belonging to or reputed to belong to George Nelson Doubleday.
- II. To authorise the Company to charge for gas supplied from works on the lands described in sub-paragraph (b) of the last paragraph hereof according to the number of cubic feet instead of according to the number of British thermal units supplied, and to exempt the Company from liability for any deficiency in the calorific value and to prescribe the maximum price of gas so supplied; and to make provision with respect to the calorific value of gas to be supplied by the Company within the existing limits of the Blaenavon Company.
- 12. To authorise the Company to continue, maintain and use any mains, pipes and other works belonging to or vested in them within the added limits and to extend and apply to such mains, pipes and other works the provisions of the Pontypool Gas and Water Acts and Orders, 1873 to 1936, and of the intended Order and of any other Act or Order relating to the Company with such exceptions and modifications as may be defined in the Order.
- 13. To empower the Company to raise additional capital and to increase the authorised capital of the Company.
- 14. To empower the Company and the Brynmawr and Blaina Gas Company (hereinafter called "the Brynmawr Company") to enter into and carry into effect agreements with respect to the purchase by the Brynmawr Company from the Company of gas in bulk, and for the purposes of any such agreement to break up streets within the limits of supply of the Company and within the urban districts of Blaenavon and Nantyglo and Blaina in the county of Monmouth and within the urban district of Brynmawr and the parish of Llanelly in the rural district of Crickhowell in the county of Brecknock and to lay mains and construct works in any streets so broken up.

15. To confer upon the Company all or any powers commonly conferred on gas undertakers and not hereinbefore referred to, to make all usual or convenient provisions incidental to the sale transfer and vesting to and in the Company of the undertakings of the Blaenavon Company and the Usk Company and for enabling them to be carried into effect, and to enact all such provisions as may be deemed expedient for effecting the purposes of the intended Order.

16. To sanction and confirm any agreement between the Company and the Blaenavon Company or the Usk Company with respect to

the subject matters of this Notice.

17. To incorporate with the Order the provisions of the Companies Clauses Consolidation Act, 1845, the Companies Clauses Act, 1863, the Lands Clauses Acts, the Gasworks Clauses Act, 1847 and the Gasworks Clauses Act, 1871 with modifications and exceptions, and to exempt the Company from some of the provisions of those Acts; to amend or repeal or apply or incorporate with the Order with or
