WE, the undersigned, being the Referees appointed under the provision of the Stockport Corporation Act, 1930, (Section II) hereby certify that we have determined the amount of the available rainfall from the drainage area of each of Works Nos. 1, 4, 7 and 8 authorised by the Act aforesaid, and the amount of each is as set out below.

From the drainage area of Work No. 1:—

Five million eight hundred thousand gallons per day.

From the drainage area of Work No. 4:—

One million seven hundred and thirty thousand gallons per day.

From the drainage area of Work No. 7:—

Seven hundred and seventy-five thousand gallons per day.

From the drainage area of Work No. 8:—

Eighty thousand gallons per day.
