(Application for Special Order under the Gas Undertakings Acts 1920 to 1934.)

NOTICE is hereby given that the Mayor Aldermen and Burgesses of the County Borough of Darlington (hereinafter referred to as "the Corporation" and "the Borough" respectively), whose address is the Town Clerk's Office, Houndgate, Darlington, intend to apply forthwith to the Board of Trade under and in pursuance of the Gas Undertakings Acts 1920 to 1934 for a Special Order (hereinafter referred to as "the Order") for all or some of the following purposes (that is to say):—

r. To empower the Corporation upon the lands hereinafter described to erect maintain alter improve and renew gas works with all necessary machinery and apparatus and thereon to manufacture and store gas and work up convert and store residual products (that is to say):—

All that piece or parcel of land situate in the County Borough of Darlington bounded on or towards the north by land belonging or reputed to belong in part to Addison Verrill and in part to Jacob Jenkins on the south in part by Chesnut Street and by land belonging or reputed to belong in part part to John Chapman and in part to A. Clarke on the east by land belonging or
